Each child needs to wear covered shoes, a hat, and sunscreen. ***Due to Covid, Gunstock Ranch Covid procedures will reflect the current state, city, and CDC guidelines. Please bring and wear a mask at all times and bring your own water bottle and a hat.***

 Pony/ Horse Walk & Petting Zoo: Gunstock Ranch staff will help children onto a horse or pony and lead them around a coned off or penned area. Children will be allowed to mingle and pet animals in our petting zoo. Animals will be in a penned-in area.

 Team Building /Field Games: Children will play age-appropriate group problem-solving games and activities.

 Mini Hike/ Walk: Children will take a short hike to our arena to learn about horses and see what they can do.

 Youth Leaders and Chaperones: We ask chaperones and youth leaders to help walk horse and watch animals at our petting zoo. Your child will be instructed how to do these tasks safely and to keep those around you safe. Covered shoes are required. Cell phone use is prohibited during this time.

Photo Release: I grant to Gunstock Ranch, the right to take and use photographs in connection with the above-identified event for any lawful purpose I authorize including for example such purposes as publicity, illustration, advertising, and web content.

Waiver / Release of Liability: I agree to allow my child to participate in this field trip at Gunstock Ranch. I recognize that there are risks inherent to this activity. I have read, understand, and assume all inherent risks associated with participating in activities at Gunstock Ranch. I understand that in order to be on Gunstock Ranch, I must give up the right to sue in the event I am injured. This waiver of the right to sue is a condition of being permitted on the ranch and to participate in activities held there.
